TERMS AND CONDITIONS FOR PROCUREMENT OF TURMERIC PROCESSING MACHINES UNDER SPECIAL ASSISTANCE FOR CAPITAL EXPENDITURE (SASCE) SCHEME, 2020-2021

 Tender should be submitted in two envelope system mentioning Bidder's Name and Address on both the envelopes. Envelopes should be superscripted "Technical Bid" or "Financial Bid" as the case may be. Both the two envelopes are then to be put in one large envelopes and must be sealed. The large envelope must also bear the Bidder's Name and Address and should be superscripted as below:

2. The sealed quotation should be addressed to:

- 3. Bids are invited for the supply of Turmeric Processing Machines ie., Turmeric Washer, Turmeric Slicing Machine, Turmeric Grinding Machine, Turmeric Packing Machine, Weighing Scale, Hand Pallet Truck, Crates and Pallets. Detailed Technical Specifications can be seen in Tender Form-I.
- 4. The 'Technical Bid' should be accompanied by duly attested Authorization Certificate from the manufacturing firm/ company of the machine. The bidders must be an authorised distributor/ dealer/ agent of the manufacturing company.
- 5. Firm having experience in the field, and proof of experience will be given priority.
- The tender must be accompanied by Booklet/ Brochure/ Write- Up which includes
 the machine description in details, detailed operation of the machines with pictures

- 7. The manufacturing company of the firm(s) should have valid BIS license and this must be supported by relevant documents duly attested. All the turmeric machineries should be designed with high quality steel i.e SS 304, 3mm thickness sheets with strong and durable bearings. The Stainless Steel used for all the machineries must conform to the Bureau of Indian Standards (BIS) and the manufacturing company must possess valid BIS licence of IS 6911: 2017.

- 11. The Financial Bid of only the tenderer(s) who are technically qualified will be opened.
- 12. The Turmeric Processing Machines ie., Turmeric Washer, Turmeric Slicing Machine, Turmeric Grinding Machine, Turmeric Packing Machine, Weighing Scale, Hand Pallet Truck, Crates and Pallets are meant for Tlangsam, Champhai District and rate must Be quoted f.o.r. destination. Cost of all the machines including installation, commissioning charges or any other charges should not exceed Rs. 41.27 lakh (Rupees forty one lakhand twenty seven thousand only). Rate quoted thus, should not exceed the upper fund limit.
 - 13. Bidder must quote for all the Turmeric Machineries to be procured by the Department.
 - 14. The "Financial Bid" should be accompanied by Earnest Money of Rs. 1,03,125.00 (Rupees one lakh three thousand one hundred and twenty five only) ie., 2.50% of quoted amount in the form of bank draft/ banker cheque duly pledged in favour of Director of Horticulture, Government of Mizoram, Aizawl.  - 15. Rates for *Turmeric Processing Machines* inclusive of all taxes, commissioning, transportation charges, etc. should be quoted clearly.
 - 16. Rates should be quoted clearly both in figure and in words, and any overwriting should be clearly initialled by the quotationer(s) with date.
 - 17. Once the rate is fixed, application for revision of rates on account of price escalation, vice-versa shall not be entertained as long as Govt. approved rates remains valid.
 - 18. Submission of proposal of Tender through e-mail/ telefax will not be accepted. The Authority will also not be responsible for postal/ carriers/ couriers delays. The Bidders must ensure submission and receipt of the application in time.

- The Performance Security may be released only after expiry of warranty period or delivery of the materials, completion of assemblage and to the iii. full satisfaction of the Department, whichever is earlier.
- 24. Any firm that has been awarded the tender shall not in any manner whatsoever handover or assign the work to any other sub-agency or third party without prior approval of Director of Horticulture, Mizoram, Aizawl.
- 25. Payment will be made only after complete installation and commissioning of the machine at its designated location and on submission of completion certificate/Bill certified by DHO/BHO concerned.
- 26. Information regarding litigation, exertions and blacklisting, if any, shall be submitted with details to enable evaluation by the committee.
- 27. Non-compliance of any of the tender terms and conditions will result in summary rejection of the tender.
- 28. In the event that any dispute or difference arises between two or more bidding firms, the Department will have no involvement whatsoever. However, in case of differences or dispute by a firm or firms against the Department, the matter maybe settled through mutual and amicable discussions. Only if such differences cannot be resolved through dialogue, the matter may then be resolved through the court of law of the State of Mizoram jurisdiction only.
