

TERMS AND CONDITIONS FOR SUPPLY AND INSTALLATION OF PRE-FABRICATED GEO LINED WATER TANK UNDER MIDH, 2022-2023

1. Tender is invited for Supply and Installation of PRE-FABRICATED GEO LINED WATER TANK under MIDH for the year 2022-2023” from **Manufacturing Company/ Authorized Dealers/ Agents, etc.**

2. Tender should be in Two Envelope Systems clearly mentioning Bidder's Name and Address on both envelopes. Envelopes must be marked as “Technical Bid” in First Envelope and “Financial Bid” in the Second Envelope as the case may be.

Both envelopes should be put in one large sealed envelope mentioning Bidder's Name and Address and should be superscribed as below:

“Tender for Supply and Installation of PRE-FABRICATED GEO LINED WATER TANK under MIDH for the year 2022-2023”

3. The sealed quotation should be addressed to:

3.1. The Technical Bid must contain the following documents:

- i) Proforma for Tender Submission
- ii) Tender Form I.
- iii) Earnest Money Deposit in the form of Banker’s cheque or Demand draft amounting to **Rs. 1,80,000.00/-** (Rupees one lakh eighty thousand) only
- iv) Attested Photocopy of Manufacturing License Certificate or Attested photocopy of Dealership certificate.
- v) Company brochure.
- vi) Attested Photocopy of GST ID/ Provisional ID of the Bidder and or the Manufacturing Company.

3.2. The Financial Bid must contain Tender Form II.

4. Submission of proposal of Tender through e-mail/ telefax will not be accepted. The authority will not be responsible for postal/ carrier delays. The bidder must ensure receipt of the application well in time.

5. In case the firm is from outside Aizawl, it must have reliable local agent(s) with office/store/godown at Aizawl detail particulars of whom including Name, Contact No. and email id, Nearest Police Station, Postal address must clearly be certified and the certificate must be enclosed in the tender document.

6. Required Technical Specification

| Sl. No. | Items/ Components | Description of Items |
|---------|--|--|
| 1. | Capacity & Quantity required | The Bidder must bid for Pre-fabricated Geo Lined Water Tank (Cylindrical Shape) of the following 2 capacities and approximate quantity required. i. 10,000 litre -135 nos. ii. 15,000 litre - 25 nos. |
| 2. | Main Frame/ structure of the collapsible water tank | The main frame of the Pre-fabricated Geo Lined Water Tank must be sturdy, with better strength and stability. The main frame layering/ structure layering may contain Wire Mesh not less than 3.1mm thickness with Zinc Coating not less than 100 GSM, drawn steel wire fabric not more than 75 x 24mm wire of weight not less than 3.3 kg per sqm, Pre-coated galvanized iron (PPGI) profile sheets and monofilament geotextile layering not less than 2200 gsm / 60 mil. The frame must be supported by Steel Angle Post of not less than 16 mm for better rigidity. |
| 3 | Waterproof Lining Materials | The waterproof lining materials that holds the stored water must conform to BIS Standard of IS 15351: 2015 for the Laminated HDPE Woven Geomembrane for Waterproof Lining (not less than 500 micron thickness). |
| 4 | Covering Materials | The Pre-fabricated Geo Lined Water Tank must have a cover. The cover must be of Anti Algae Woven Polypropylene materials of 90% UV stabilized. |
| 5 | Fasteners and other Accessories | The Pre-fabricated Geo Lined Water Tank unit must contain (Chlorinated Polyvinyl Chloride) CPVC Gate Valve, Tank nipple, Nut Bolt, MS Clamp, Cable Tie, etc. and other necessary repair kit. |
| 7 | Warranty and Guarantee | Free maintenance of the unit for a period of not less than 1 (one) year from the date of installation of the unit. In case of complaints regarding leakage within valid warranty period, the firm shall repair or replace without extra charge. |

7. The Manufacturing company must have valid BIS/ISO Certificate as the case may be, and attested copy of the same should be submitted along with Tender documents.

8. The Pre-fabricated Geo Lined Water Tank must have ISI marking.

9. NSF Certificate in respect to HDPE Woven Fabric Geomembrane should preferably be submitted along with bid documents.

10. Chlorination certificate from a concerned authority should be submitted alongwith bid documents.

11. Valid manufacturing license (if the Tenderer is manufacturing firm/company) or valid Authorization/ Dealership certificate from manufacturing company (for Tenderer other than manufacturing firm/company) must be submitted along with Tender documents.
12. Manufacturing company Brochure relating to the items required by the Department must be submitted along with Tender documents. The Brochure must also contain the company profile and diagrams of the Pre-fabricated Geo Lined Water Tank.
13. **Sample:** Miniature sample of the unit with the correct dimension ratio should be submitted at the time of opening tender.
14. The Bidder i.e., Authorized Dealer/ Agent/ Firm and the Manufacturing Company must have separate valid GST ID or Provisional ID, duly attested photocopies of which must be enclosed. In case of direct participation by the Manufacturing Company, duly attested valid GST ID or Provisional ID of the company alone will suffice.
15. Bidders having experience may be prioritized on condition that there is proof of documents duly attested.
16. Earnest Money Deposit (EMD) amounting to **Rs.1,80,000.00** (*Rupees one lakh eighty thousand only*) i.e. approximately 2.5 % of the tendered amount for Supply and Installation of Pre-fabricated Geo Lined Water Tank must be submitted along with tender documents in the form of either Account Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee from any of the Commercial Banks duly pledged in favor of Director of Horticulture, Government of Mizoram. The same will be released after finalization of the tender.
17. The tenderers should clearly quote their rates inclusive of all taxes F.O.R destination which can be anywhere within Mizoram including installation. The tenderer should write the quoted rate of each item both in figure and in words. Overwriting in the rate quotation (if any) should be clearly initialed by the quotation(s).
18. Once the rate is approved, it shall be final and shall be valid for 1 year w.e.f issue of Supply Order and shall not be allowed for sub contracts. The approved rate for every item is not negotiable even if there is change or increase in manufacturer's price or price escalation during validity period of the Govt. approved rate.
19. The Department reserves the right to accept/reject any tender/all tenders without assigning any reason thereof and is not bound to accept the lowest quoted rate (s).
20. Any tender not completing with the requirement/fulfill with the terms and condition may summarily be rejected or may be considered invalid.

21. In case of any legal disputes, litigations arising out of this Tender, the matter shall be heard and settled through mutual and amicable discussions. Only if such differences cannot be resolved through dialogue, the matter may then be resolved through the court of law of the State of Mizoram jurisdiction only.

22. If any bidders suppress any fact which could debar him from participation in the tender and the truth is revealed to the tendering authority subsequently, the bidder will be liable for legal prosecution as well as other stern action by the tendering authority within his / her jurisdiction, and the received tender will be rejected and deposited earnest money with the tender will be forfeited.

23. **Supplier and Supply Order:** The successful Tenderer will be termed as '**Supplier**' on issuance of Supply Order. Supply Order will be placed by the Director of Horticulture.

24. Successful Tenderer, before issue of supply order, must inform the Department of his /her details such as Bank Account Number, Name of Bank, Name of Bank Branch, Bank IFSC Code, Contact Number and any other information deemed necessary by the Department.

25. Performance Security:

- i. The successful Tenderers (irrespective of category), if awarded supply order should submit Performance Security amounting to 5% of the supply amount in the form of bankers' cheque payable at any Nationalized Bank duly pledged in favour of Director of Horticulture, Mizoram, Aizawl duly before starting of work/ supply.
- ii. The Performance Security shall be released after satisfactory completion of supply and installation of the materials.
- iii. The Performance Security will be liable to be forfeited if the supplier withdraws or amends or impairs or derogates from the tender in any respect.

26. Completion period:

Work should be completed within 90 days from the date of issue of Supply Order. Incompletion of work during the stipulated time shall be conveyed to the Director of Horticulture after which necessary action will be taken by the Director of Horticulture.

27. Time extension:

Supplier should execute the work within stipulated delivery period, However, if contractor foresee that due to any reason beyond their control, they may not be able to maintain the delivery schedule, they should apply for time extension period (not more than 30 days) at a time on the basis of documentary evidences and valid ground. The Department of Horticulture reserves the right to consider or reject the time extension prayer of the supplier. If any time extension prayer is rejected by the tendering authority, and supplier fails to maintain the stipulated delivery schedule, performance security in part or in full as may be decided by the Director of Horticulture will be forfeited.

28. Extraneous terms and conditions:

Bidder should accept all the terms & conditions of the tender unconditionally and if he or she impose any extraneous term condition or offer any conditional discount, tendering authority reserves the right to declare the bid informal.

29. Explanation / clarification of tender:

If any bidder requires any explanation or clarification of any of the terms and conditions of the tender, it must be sought from the tendering authority before participation in the tender.

30. Amendment to Tenders:

The tenderer, after submitting its tender, is permitted to submit alterations/modifications to its tender so long such alterations/modifications are received duly sealed and marked like original tender upto the date & time of receipt of tender. Any amendment/modification received after the prescribed date & time of receipt are not to be considered.

31. The Procuring Authority and the bidder concerned shall sign the procurement contract within a period of 21 days after the letter of acceptance is dispatched to the bidder concerned.

32. The Department reserves the right to either increase or decrease the required quantity of the items at the time of the contract without any change in the unit price or other terms & conditions of the bid and the bidding documents.

33. Repeat orders for additional quantities of the items may be placed within the bid validity period, supplier must supply items at the same rate following the same terms & conditions.

34. If the Procuring Authority does not procure any of the tendered quantities of subject matter of procurement or procures less than the quantity indicated in the bid documents due to changed circumstances, the bidder shall not be entitled to any claim/compensation.

35. Full payment will be made only after completion of the work satisfactorily. However, part payment may be given depending on the progress of the work.
