# TERMS AND CONDITIONS FOR SUPPLY OF PLANT PROTECTION CHEMICALS / PLANT NUTRIENTS UNDER MIDH, 2023–2024

1. Tender should be in Two Envelope System clearly mentioning Name of Items, Bidders Name and Address on both envelopes. Envelopes must be marked as "Technical Bid" in First Envelope and "Financial Bid" in the Second Envelope as the case may be. Both envelopes should be put in one large sealed envelope and should be superscribed as below:

"Open Tender for supply of Plant Protection Chemicals / Plant Nutrients under Horticulture department for the year 2023 – 2024"

2. The sealed quotation should be addressed to:

- 3. The First Envelope should be Technical Bid containing
  - i) Tender Submission letter as per prescribed proforma
  - ii) Tender Form I.
  - iii) Earnest money deposit.
  - iv) Attested Manufacturing License Certificate/Dealership certificate.
  - v) Attested Pesticide/Fertilizer License
  - vi) Attested Tribal certificate (in case of tribal).
  - vii) Company brochure.
  - viii) Attested copy of valid GST payment by the tendering firm.
- 4. The Second Envelope should contain Financial Bid in Tender Form II.
- 5. First Envelope will be opened first and the Second Envelope will be opened only for those valid/accepted First Envelope on the same day.

Earnest Money @ 2.5% amounting to Rs. 30,000/- only for Plant Protection Chemicals and Rs. 1,25,000/- only for Plant Nutrients must be submitted along with tender documents in the form of Account Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee from any of the Commercial Banks duly pledged in favour of Director of Horticulture, Government of Mizoram. The same will be released after finalization of the tender. In cases where tender bid is made for both P.P Chemicals and Plant Nutrients, the EMD amount will be = Rs. 1,55,000/- (30,000/- + 1,25,000/-) only.

7. The Tribal Tenderer(s) should furnish attested copy of Tribal Certificate duly issued by the competent authority, and should produce the Original Copy of Tribal Certificate at the time of opening the Tender.

- 8. The tenderer(s) should enclose attested photo copy of valid license issued by Licensing Officer, Govt. of Mizoram and the original copy should be produced at the time of tender opening.
- 9. Photo copy of GST Registration Certificate attested by Gazetted Officer should be enclosed.
- 10. Authorized Dealers having valid Pesticides License submitting their Tenders should attach photo copy of valid Authorization/ Dealership/ Distributorship Certificate from the concerned Principal Manufacturers duly attested by the Gazetted Officers/Notary. Original Certificate should be produced at the time of opening of Tenders.
- 11. The tenderers should clearly quote their rates inclusive of all taxes F.O.R Aizawl. The tenderer should write the quoted rate of each item both in figure and in words. Duly prescribed tender form should be collected from Plant Protection Section, Directorate of Horticulture, Mizoram, Aizawl. Any overwriting in the rate quotation should be clearly initialed by the quotationer (s).
- 12. In case of any legal disputes, litigations arising out of this Tender, the matter shall be heard and settled in the court of law at Aizawl only.
- 13. Tenderers should bring samples bearing name of the Tenderer on the packing during the opening of Tender, for further production before DPAB. Any samples submitted by the Tenderers cannot be claimed back even if not selected. Every sample item should bear the name of the firm of the tenderer(s).
- 14. Tender must be accompanied by manufacturing company brochure for item(s) for which rate quotation is given.
- 15. Once the rate is approved, it should be final and shall not be transferable to any person(s) or firm(s). The approved rate for every item is not negotiable even if there is change or increase in manufacturer's price during validity period of the approved rate.
- 16. Successful Tenderer, before issue of supply order, must inform the Department of his / her details such as Bank Account Number, Name of Bank, Name of Bank Branch, Bank IFSC Code, Contact Number and any other information deemed necessary by the Department.
- 17. The successful Tenderers (irrespective of category), if awarded supply order should submit Performance Security to Director of Horticulture, Mizoram, Aizawl amounting to 5% of the supply amount in the form of bankers cheque payable at any Nationalized Bank duly pledged in favour of Director of Horticulture, Mizoram, Aizawl duly before starting of work/supply. The Performance Security shall be released after completion of supply of the materials satisfactorily.

- 18. The Performance Security will be liable to be forfeited if the supplier withdraws or amends or impairs or derogates from the tender in any respect.
- 19. The Department reserves the right to make procurement only from known and reliable manufacturing companies/ certified dealers to avoid purchase of sub-standard or poor quality materials.
- 20. The Department reserves the right to accept/reject any tender/all tenders without assigning any reason thereof and is not bound to accept the lowest quoted rate (s).
- 21. The successful tenderer (s), if awarded supply order, will have to supply the materials within the period fixed by the Department/Authority. If the supply cannot be completed within the stipulated period with or without any intimation, the Authority has the right to procure the materials from any other sources without assigning any reason thereof.
- 22. Supplier should complete the supply within stipulated delivery period. However, if the supplier for any reason beyond his/her control, is not be able to maintain the delivery schedule, he/she should apply for time extension period at a time on the basis of documentary evidences or valid ground. The Department of Horticulture reserves the right to consider or reject the time extension prayer of the supplier. If at any time, extension prayer is rejected by the tendering authority, and supplier fails to maintain the stipulated delivery schedule, performance security in part or in full as may be decided by the Director of Horticulture will be forfeited.
- 23. The supplier will have to supply the Plant Protection Chemicals/ Plant Nutrients having shelf-life/active period at least one year validity from the date of delivery of supply and the same must be clearly displayed in a printed form on the package/container. The supplier will have to supply the materials exactly the same quality as of the sample submitted at the time of opening of the tender.
