- 1. Tenders are invited only from registered and reputed manufacturers or authorized dealers/distributors of the tendered items mentioned in the annexure / I.
- If the bidder is manufacturer, a photo copy of valid Manufacturer Statutory Registration Certificate attested by Gazetted Officer of either Central or State Govt. or Notary should be enclosed along with tender documents.
