**TENDER TERMS AND CONDITIONS FOR PROCUREMENT OF NON- MOTORIZED  
MOBILE VENDING CART UNDER MIDH**

1. Tender should be submitted in two envelope system mentioning Name of Item, Bidder's Name and Address on both the envelopes. Envelopes will have to be marked as "Technical Bid" or "Financial Bid" as the case may be. Both envelopes are to be put in sealed envelop superscribed as below:

"Quotation for non-motorized mobile vending cart under MIDH"

2. The sealed quotation should be addressed to:

3. Tender is invited for mobile vending cart with the following specifications:-

<b>Particulars</b>	<b>Details/ Descriptions</b>
i) Purpose	Selling of horticulture produce specially vegetables and fruits.
ii) Capacity	100 Kg
iii) Wheels a) Front wheels b) Rear wheels	3 Nos. 2 nos., Size of 24 cm with rubber tires 1 no. of 360° rotation rollers
iv) Over all bed size	Length : 150 cm Breadh : 60 cm
v) Shelves	The vending cart should have door opening backside duly mounted on 4-wheeler non-motorized with shelves of 4-5 compartments.
vi) Total length of Vending Cart with handle	200 cm
vii) Height of Vending Cart without canopy	150 cm
vii) Brake system	i)The braking system will consist of two brakes one each in both of the front wheels, which will be operated from the handle of the vending cart. ii) The two brake pads of the front wheels should be mounted to the wheel rim of the two front wheel on the left and right.

ix) Brake pad	Reinforced rubber pads
x) Materials	Galvanized steel frame of build to last for not less than 10 years.
xi) Types of structure	Non motorized
xii) Warranty and Guaranty Services guaranty period as	The firm should provide maintenance/ warranty one year or more per company offer.
xiii) Services	The firm has to give free maintenance services for one year.

4. Interested bidder/ firm can give its own specification and design (both 3-D and sectional design) which can be considered by the Department.
5. The firm may also give their own specifications, design and parameters for consideration by the committee. This should also be supported by both 3-D and sectional design.
6. The financial bid of only the tenderers who are technically qualified will be opened.
7. The requirement of non-motorized Vending Carts is under the scheme MIDH 2016-2017 and 2017-2018 with fund provision of Rs. 28.5 and Rs. 30.00 lakh respectively.
8. Rate quoted should not exceed the upper limit of Rs. 15,000.00 per Vending Cart.
9. The tender should be accompanied by Earnest Money of 2.50% of quoted amount in respect of non-tribal and 1.25% quoted amount in respect of tribal in the form of bank draft/ banker cheque duly pledge in favour of Director of Horticulture, Government of Mizoram, Aizawl. Release of the same may be done as per rule by the Department after finalization of tender. In case of Tribal bidders attested tribal certificate must be enclosed.
10. Firm with experience in Vending Cart must enclose relevant documents.
11. The firm/ bidders should be authorized distributor/ manufacturer duly registered having valid GST provisional ID, copy of which must be enclosed.

12. Rates per unit/no. should be quoted clearly both in figure and in words, and any overwriting should be clearly initiated by the quotationer(s) with date. The currency for the purpose of this tender shall be Indian Rupee. Any other form of currency shall be a cause for rejection of the bid.

**13. Performance Security:**

- i) The successful tender, if given Supply Order, must deposit Performance Security of amount not less than Rs. 3 lakh and not more than Rs. 6 lakhs of the total value of Supply Order. Actual amount shall be mentioned in Supply Order.
- ii) The Performance Security will be liable to be forfeited if the successful tender break/ withdraws/ amend impairs or derogates from the tender on any respect.
- iii) The Performance Security may be released only after expiry of given period provided the material were delivered and assembled with full satisfaction.

14. The firm shall not assign or submit the contract without written approval of Director of Horticulture, Mizoram, Aizawl.

15. No advance payment will be made on supply and assembling of non-motorised Mobile Vending Cart.

16. 1% cess will be deducted from total value of order.

17. Payment will be made only after receipt of materials in full and in good conditions and / or after assemblage whatever the case may be, on submission of completion certificate/ Bill accompanied by tax clearance certificate duly utilized by competent authority.

18. Information regarding litigation, exertions and blacklisting, if any, shall be submitted with details to enable evaluation by the committee.

19. Non-compliance of any of the tender terms and condition will results in summary rejection of the tender.
